UNIVERSITY HEIGHTS HISTORY CORNER

Did you know that the original plat of University Heights had a street named Bryn Mawr Ave., one named Oberlin Ave, there was no Trinity Ave, and Harvard Ave. followed a different path? In 1914, the Trustees of University Heights issued a Notice of Change of Name of Streets:

Be it known that the undersigned, duly chosen and appointed Trustees......have, for the purpose of convenience, changed the names of the following streets located in said subdivision, to wit:

Street formerly known as Harvard Ave., commencing on the North side of Delmar Ave. and running northwardly two blocks to Cornell Ave., changed to Trinity Ave.

Street formerly known as Bryn Mawr Ave., commencing at Cornell Ave. and running northwardly three blocks to Dartmouth Ave., changed to Trinity Ave.

Street formerly know as Oberlin Ave. commencing on the North side of Delmar Ave. and running northwardly about one block to the private way fronting Lots 1 and 2 in Block 2, changed to Harvard Ave.

University City's City Hall is located in Block 4 of our subdivision, and was originally the Office Building for E.G. Lewis's "Woman's Magazine". All lots in Block No. 1 and lots 1 and 2 of Block 2 were reserved for places of business (now Delmar-Harvard school). Lots 1 to 7 and 31 to 34 of Block 3 were reserved for a public high school or common school (now homes on Harvard and Trinity) and Blocks 1 and 2 of Block 6 were reserved for a place of public worship (now homes on Princeton and Trinity). Lots in Block 10 and lots 24, 25, 26 and 27 of Block 12 and lot 20 of Block 2 (the North side of Dartmouth and end of Yale and Harvard) were originally exempt from the stipulations in the indenture, and instead reserved for future stipulations to be determined by the Company. The indenture was amended in 1926 to make these lots subject to the same stipulations as other residential lots.

••••••

The indenture also set minimum costs for dwellings erected upon any of the lots in the subdivision. The minimum cost originally ranged from \$1,500 to \$6,000!! In 1921 the indenture was amended so that the minimum cost was raised to a range from \$2,500 to \$10,000!!

Spotlight on Health By Dr. John Thomas

Summer is finally here. The rains are still coming down. I guess the drought is finally over. Sunny skies are hiding out there somewhere. Now is a good time to talk about protecting your skin.

Skin cancer is a growing problem in the population. The emphasis on beauty is strong in our culture. Many of us feel that having a tan is a symbol of health and beauty. When the skin is exposed to sunlight, it produces vitamin "D". Normal exposure to the sun is sufficient for normal health. Sun bathing is harmful to the skin. Over exposure to the sun causes the skin to thicken and wrinkle. People with fair complexions are at greater risk of skin damage. If you have freckles or natural red hair, you have a great risk of developing skin cancer.

Research shows that a single incidence of sunburn at a young age is the leading cause of developing skin cancer later in life. When out doors, always cover your skin. If you will be exposing a lot of skin, always use a skin protecting lotion. Always examine your skin after you bathe. Look for signs of sunburn. If the skin is hot and red, you probably have sunburn. Treat with ice and Aloe Vera. Always look at your moles for signs of change. Your physician should always examine moles that change shape, change color, or bleed. Please note that using a tanning booth will not protect you from developing skin cancer.

It is also important to protect your eyes when outdoors. Macular degeneration is a leading cause of blindness in seniors. Macular degeneration is of greater incidence in fair skinned people. Exposure to ultraviolet light may be an agent in this disease. When outdoors, always wear sunglasses that filter out ultraviolet radiation. Protecting your skin while young leads to healthy skin in your later years.

APPROVAL BY RESIDENTS TO AMENDMENT OF

DECLARATION OF TRUST AND AGREEMENT OF THE UNIVERSITY HEIGHTS SUBDIVISION NO. 1

THIS INSTRUMENT, executed by a majority of the owners of lots in the UNIVERSITY HEIGHTS SUBDIVISION NO. 1 (hereinafter referred to as University Heights) as an Amendment and Declaration of Trust and Agreement, dated January 19, 1905, made and entered into by the University Heights Realty & Development Company, as the same has been amended from time to time (hereinafter collectively referred to as the "Trust Agreement"),

WITNESSETH:

WHEREAS, the purpose of the Trust Agreement was to create a high grade residence district and that the said purpose has been fulfilled in that said University Heights Subdivision has been established, developed and maintained as a high grade residence from and since its establishment until the present day.

WHEREAS, that the Trust Agreement originally provided for a maximum assessment of \$0.25 per front foot per year and that such maximum amount was modified by two orders of the St. Louis County Circuit Court, one in 1957 raising the maximum assessment to \$0.50 per front foot and one in 1979 raising the maximum assessment to \$1.50 per front foot.

WHEREAS, that the Trustees are not receiving sufficient income from the assessments provided for in the Trust Agreement to continue to maintain University Heights as a high grade residence district.

WHEREAS, that Section 6 of the Trust Agreement provides for a plan of amendment of the Trust Agreement, but that said Section 6 has been declared to be inoperative by the Supreme Court of Missouri in the case of <u>In Re Buckles</u>, 53 S.W.2d 1055 (Mo. 1932).

NOW, THEREFORE, a majority of owners of the lots in University Heights, determined both by front footage and assessed value do hereby agree as follows:

- 1. That because the amendment provisions of the Trust Agreement were determined to be inoperable by In Re Buckles, all actions possible should be taken by the Trustees or other interested parties to have a court of competent jurisdiction strike the portion of the amendment provision of the Trust Agreement which renders it inoperable.
- 2. That a reasonable modification of the Trust Agreement would be to permit the Trustees to collect an amount not in excess of Three Dollars (\$3.00) per front foot per year in lieu of One Dollar Fifty Cents (\$1.50) per front foot per year, as provided in the Judgment and Decree of the St. Louis County Circuit Court dated January 5, 1979.
